

2019 RVX GIVEAWAY

OFFICIAL SWEEPSTAKES RULES

1. You must be a legal resident of the United States and 18 years of age or older to enter. One entry per person. The sweepstakes is void where prohibited by law.
2. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. NEED NOT BE PRESENT TO WIN.
3. Sweepstakes will begin on Friday, January 4, 2019 at 12:00 am Eastern Time and end on Thursday, January 31, 2019 at 11:59 pm Eastern Time.
